- Scheduled game times are approximations. Please be prepared to play games ahead of schedule.
- Carded officials will be provided.
- Please bring your own well-marked volleyballs for warm-up.
- There will be a small coaches/officials located at each venue.
- The A.S.A.A substitution rule will be used. A team shall be allowed to a maximum of 12 substitutions in any one game. A player may leave and re-enter the game, but only for the same player. Unlimited substitutions are allowed up to 12 per game.
- The tie-breaking procedure will be the A.S.A.A. **AND WILL NOT BE USED TO ELIMINATE TEAMS**

If two or more teams are tied at the end of the preliminary round,
the following criteria will be applied in order:

THE TEAM HAVING THE BEST RATIO OF:

- a. won / lost matches, considering matches played between tied teams
- b. won / lost games, considering matches played between tied teams
- c. won / lost games, considering all matches played during the round robin
- d. points for / against, considering games played between the tied teams
- e. points for / against, considering all games played during the round robin
- f. tournament director will determine the next step
